125 York Road – 25/10054/CPLB – 15.1.2025. Secondary glazing to windows. Decided 11.2.2025 Certificate of Lawfulness be issued.

3 Richmond Avenue – 25/10368/VC – 28.1.2025. Ash, Holm Oak and Hazel – Remove any dead, diseased or mechanically compromised material and reduce shoots by up to 2.5m where necessary. Decided 28.1.2025 – Preservation Order not required.

139 Ashley Road – 25/10114/CE – 29.1.2025. Application for a Lawful Development Certificate for an Existing Use or Operation or Activity – The lead valley was replaced on the roof, as well as re-bedding of hip tiles and new membrane and wooden battens replaced.
